



The January 26, 2016 contribution from Linda Bowlin to Keep Revenue in Randolph County was made in cash while Ms. Bolwin was opening the Keep Revenue in Randolph County bank account. After becoming aware of the legal restrictions on cash contributions and after consulting with legal counsel, Keep Revenue in Randolph County corrected the error by refunding the \$1,000 cash contribution made by Ms. Bowlin. Ms. Bowlin subsequently issued a personal check in the amount to \$1,000 to Keep Revenue in Randolph County. The refund and the subsequent contribution were made on February 9, 2016 and will be noted on Keep Revenue in Randolph County's Financial Report covering the period February 1, 2016 through February 29, 2016 that is due to be filed on or before March 15, 2016.
