

Arkansas Wins in 2016, LLC will advocate the qualification and passage of an amendment to the Arkansas Constitution to authorize the operation and regulation of one or more casinos and casino gaming in the State of Arkansas. Casinos allowed under this Amendment shall be limited to no more than one casino in each of the following Arkansas Counties and operated by the licensee so designated: Boone County, operated by Arkansas Gaming and Resorts, LLC; Miller County, operator to be determined; and Washington County, operator to be determined. Assuming qualification of the proposed Amendment, this ballot question would be presented to a popular vote at the General Election in November 2016.
